Hampton Court House is pleased to announce that we may be running a trip to Kenya during the October half-term in 2012. We plan to offer year 7-11 students a life changing, unique opportunity as they travel to see and experience a life so very different to their own.

A brief guide to our planned itinerary is:-

- Flight out
- Minibus travel to Masai Mara (about 5 hours)
- 2 days in the Masai Mara
- Minibus travel to Nakuru (about 5 hours)
- 1 day in Nakuru,(including some time in the game reserve)
- Mini bus travel to Marich Pass (about 7 hours)
- 5 days in Marich Pass, visiting local schools, local villagers, local markets, relaxing, enjoying the countryside, marshalling a road race, getting to know the people and usually taking part in some projects to help the local area.
- Minibus travel back to Nairobi (long trip), overnight stay in Nairobi and flight home

No one needs to be afraid of the food; it is good, plain, plentiful and safe. For most of the trip the water is drinkable, and we buy bottled water for the rest.

The costs **£1,500** (payments can be made in instalments up to July 2012). This cost includes flights, hotels, food (breakfast, lunch and dinner), transport in Kenya, fees for guides and entrance fees to all safari parks. Costs that are not included are passport, VISA, spending money and pre-trip medical precautions.

If you are interested in allowing your son/daughter to participate in this exciting experience could you please complete and return the attached form. This form is only to register interest – not to confirm a place on the trip.

There will be a meeting at 6.30pm on Monday 30th January where the trip will be explained in detail and this will also give you a chance to ask any questions.
